HISTORICAL SKETCH

The 8th New York Cavalry, or "Rochester Regiment," was organized at Rochester in November 1861, and mustered out of service in June 1865.

SCOPE AND CONTENT NOTE

The 8th New York Cavalry Records, formerly part of the Civil War Collection, consist primarily of reports, returns, requisitions, and other records relating to the Quartermaster's Department, while the regiment served in Virginia and Maryland from 1862 to 1865. The collection also contains some records of the Ordnance Department and the Subsistence Department, and some quartermaster's records of the 9th New York Cavalry.

The collection is arranged in the following series: **Quartermaster's Department Series**, **Ordnance Department Series**, and **Subsistence Department Series**. Within each series, the papers are arranged numerically by the number of the form. Documents that do not have a form number are filed after the numbered forms at the end of each series. (For an explanation of the forms used, researchers should consult *Revised Regulations for the Army of the United States, 1861*; available in the Missouri Historical Society Library, call number 973.7418/Un3r.)

Some of the documents are in fragile condition.
