**BIOGRAPHICAL SKETCH**

Mrs. Cynthia Neff (nee Gillespie) married Manlius Hewitt July 1, 1868, in St. Louis, Missouri. Cynthia A. Hewitt died November 2, 1896, in St. Louis; Manlius Hewitt died in July 1912 in St. Louis.

**SCOPE AND CONTENT NOTE**

The collection consists primarily of personal correspondence of the Hewitt-Neff family, including several letters sent to Mrs. Cynthia A. Hewitt and several letters of Frank Adam Neff to his mother. The collection also includes business cards and invitations.

- 1867 Jan 18[?] Letter signed J. King Gillespie, Ballston Spa, New York, to "My dear Widowed Sister" (Mrs. Cynthia A. Neff), St. Louis, Missouri. Informs his sister of the death of his wife.
- 1868 Sept 29 Letter signed W.E. Munsey[?], Embreeville, Tennessee, to his sister Annie. Mentions family members and a servant who are sick with typhoid fever. Invites her to travel with him to Baltimore.
- 1870 Jan 20 Handwritten note: Miss Onie[?] Aglar's Compliments to Mr. Mudge for Thursday evening, January 20th 70."
- 1870 July 28 Letter signed Will, Saint Louis, to his sister Cynthia. Mentions that there have been many deaths from sun stroke, and that he has made a strike for higher wages.
- 1870 Nov 30 Note signed Clara Seavey to Mrs. Hewitt; "I will call and see you to morrow after-noon if it will be convenient for you. answer soon my cousin will call for the answer this evening after school, and oblige as ever Friend."
- 1871 Apr 30 Letter signed Geo. Mudge to Mrs. Hewitt. Thanks Mrs. Hewitt for her kindness, and mentions that he expects to start up the Missouri River next week.
- 1871 June 21 Letter signed Will H. Parsons, Ironton, to his sister Cynthia. ". . . We are nicely Settled in our new Home. . . Meats are Cheaper here than in St Louis the best is 10 cts per Lb. wood \$3 [or \$5] per Cord. . . ."
- 1871 July 21[?] Letter signed Willie Neff, Jefferson City, to his brother. Willie, a young boy, describes a picnic he went on with Maggie Rice. Mentions that "Mrs. Rice took Harvey[?] the Colered boy."
- 1871 Aug 28 Letter signed P. Bardin, Ironton, to Mr. & Mrs. Hewett. Informs them of the sickness and eventual death of Will, and that "Willie lies also at the point of death & no hopes of his recovery."
- 1872 Jan 16 Letter signed J.H. Hill, San Jose, [California], to "My Dear Hewetts." Mentions the ruins of "desolated Chicago" in the wake of the fire. Describes his train trip from Chicago to San Francisco, including an account of being blockaded by snow in the Rocky Mountains.
- 1875 Aug 14 Printed invitation to the marriage of Don Turner and Josephine Eckert at the residence of H.C. Talbott, Waterloo, Illinois. Invitation is in envelope addressed to Mr. and Mrs. Hewett, Belleville, Ills. (Hinckley House).
- 1877 June 5 Letter signed George, Post No. 1, Tongue River, Montana, to "Dear Mother

& Brother.” He writes that he expects to go up to the Big Horn on the next train, an area that is believed to have rich mines. (The envelope that appears to accompany this letter is addressed to Mrs. C.A. Hewett, Hinkley House, Belleville, Ill.)

- 1877 June 25 Letter signed Geo. Neff, cantonment on Tongue River, Montana, to mother and brother. “. . . I have turned over a new leaf since I left St. Louis, and I feel like there was something to live for and hope I will never be Broke again. . . .” Mentions that Indians jumped the mail carrier and stole the mail.
- 1877 July 18 Letter signed Geo., Tongue River, to “Dear Mother & Bro.” He writes that he hopes to get over his bad habits; military law is in effect where he is residing; whisky is forbidden; and everyone must be in bed by 9. Also mentions the recent visit of Gen. Sherman.
- 1877 Sept 22 Letter signed Pearce, Fargo, to his mother. Mentions that “we have sold out all the beef cattle.” Provides an account of the death of George Neff, who was found laying by the side of the railroad track about 25 miles from Fargo with his neck and back broken. It is supposed that he fell off a railroad car while attempting to steal a ride.
- 1880 Jan 11 Letter signed Annie, Clinton, to Willie. Discusses family news.
- 1880 Nov 14 Letter signed Sarah, Harrison, to her sister. Discusses family news. Mentions that the grain is all in the bins and the potatoes have been placed in the cellar. Mentions dresses and pants that she has made for her children. Mentions Clara Masters.
- 1881 Feb 4 Letter signed J. King Gillespie, Auburn, New York, to “My Dear Sister” [Mrs. Cynthia Hewitt]. Gillespie writes that it is unlikely that he will be able to come to St. Louis in March, due to work demands. He also notes that he is on crutches.
- 1881 Apr 7 Letter signed Sarah, Harrison, to her sister. Asks her sister to buy some cloth for her for a dress she plans to make.
- 1885 July 20 Note signed A.B. Covey, St. Louis, Mo., to Mrs. Hewitt. Mentions that Belle has had a baby named “A.B.C. Jr.”
- Circa 1886 July 8 Account regarding balance due from M. Hewett to O.F. Greer [or Green].

- 1891 June 25 Printed invitation of Mrs. E. Suydam to the marriage of her daughter Mamie Suydam to Louis Harris at the residence of Mrs. J.D. Harris in Harrison, Minnesota.

Mentions that his attorney has begun divorce proceedings for him, and is negotiating with a lawyer named Luke Hart. Mentions that he saw John Dickinson of Little Rock. (Letter is written on stationery of The Fisk Rubber Company, Quincy, Illinois.) Encloses copy of typescript letter of Frank Adam Neff, 5900 Clemens Ave., St. Louis, Mo., to Local Board for Division No. 27, 1902 North Union Ave., St. Louis, Mo. States that he is registered as residing at 5812 Romaine Place, but asks that any mail from the board be sent to 5900 Clemens Ave. (Envelope is addressed to Mrs. S. Neff, 5900 Clemens Ave., St. Louis, Mo.)
- 1918 Dec 8 Typescript letter signed Frank to his mother. Discusses his job and his divorce case. (Letter is written on stationery of The Fisk Rubber Company, Quincy, Illinois. Envelope is addressed to Mrs. S. Neff, 5900 Clemens Ave., St. Louis, Mo.)

- 1919 Feb 20      Typescript letter signed Frank to “My Dear Mother and Tracy and All.” Discusses his divorce proceedings. Hopes Vic Allan can influence the judge.
