William H. Ashley's grand-niece, Mrs. Ben F. Gray, donated Ashley's diaries, the Rogers journals, drafts of letters and some business papers to the Missouri Historical Society in 1908.

RESTRICTIONS

Researchers must consult the microfilm and/or published versions of the William H. Ashley diary (March 25-June 27, 1825) and the two Harrison G. Rogers journals (November 26, 1826-January 27, 1827, and May 10-July 13, 1828) before these items will be paged to the reading room.

BIOGRAPHICAL SKETCH

William H. Ashley was born in 1778 in Virginia, the county of his birth being variously given as Powhatan or Chesterfield. He came to Missouri between 1803 and 1805, when he was listed as an inhabitant and freeholder in Ste. Genevieve. Ashley had both a political and military career in Missouri, as justice of the peace for Ste. Genevieve after 1806, and as a captain (later colonel and general) in the Missouri militia. During the War of 1812, he manufactured gunpowder in Potosi and he was commissioned lieutenant colonel in the Washington County militia in 1814.

Moving to St. Louis in 1819, Ashley continued his political career as a candidate for lieutenant governor and president of the senate. Throughout the 1820s, Ashley was a participant in the fur trade, taking a number of hunters into the Rocky Mountains beginning in 1821 and made his last journey to the mountains in the spring of 1826, selling his interests in the fur trade to Smith, Jackson and Sublette. He continued to supply trade goods and supplies for the fur trade, but focused on politics, as congressman from Missouri, 1831-1834. Ashley died of pneumonia March 26, 1838.

SCOPE AND CONTENT NOTE

The William H. Ashley Collection consists of his diaries, drafts of letters, and some business papers. Documents are arranged in chronological order, ending with a reference file that contains genealogical and biographical information on Ashley.

Ashley made several journeys to the Rocky Mountains from 1821 to 1826. The collection contains a draft, or copy, of his later account and his diary for the journey made in 1824 and 1825. At one time Ashley's diary was mistaken for that of William Sublette. This has been corrected but is still evident on the typescript of the diary (folder 5). The Harrison G. Rogers journals contain accounts of expeditions made with, and for, Jedediah S. Smith. After his death

in 1828, Rogers' journals were recovered from the Umpqua Indians by Jedediah Smith and turned over to William H. Ashley as executor of Rogers' estate.

The collection contains drafts of letters that might possibly be notes (folders 17-18) that relate to Ashley's observations and recommendations for a military presence in the Rocky Mountain region. It is estimated that these were written circa March 1829.

Items identified as not having been donated as part of the Ashley Collection have been returned to their original collections. A list of these manuscripts follows the document inventory.

Fragment of letter begins: "It seems that this design . . ." Sublette's traders have sold goods to Indians; attacks of Blackfoot Indians on William Tullock, and plunder of furs; need of military force to protect the fur trade. (3 pages)

Fragment of letter begins: ". . . to the Blackfeet – This fact was communicated . . ." Blackfeet Indian attack; wealth of the Hudson Bay Co. Believed to be fragment of a draft of Ashley's letter to Thomas Hart Benton, January 20, 1829. (3 pages)

Draft of letter (fragment) begins: "When writing to you on the 20th . . ." Rocky Mountain region and military establishment at the mouth of the Columbia River. (2 pages)

4. Undated fragment. Draft begins: "In compliance with your request in situation . . ." Descriptions of manner of equipment and moving parties of men through Indian country. (partial leaf, 2 pages)

Nine drafts estimated to have been written circa March 1829:

1. Draft of letter. Draft begins: "and will not therefore yet commence hostilities . . ." Possibility of Pawnee Indians moving to the head waters of the south branch of the Platte River, to operate

with the Arapahos, Kiowas and Blackfoot. Very similar to above fragment, not readily identifiable as Ashley's handwriting but matches that in his diary of 1825. (4 pages)

2. Draft of letter/notes (fragment). Draft begins: "The several tribes with whom we have intercourse west of the mountains . . ." Estimates numbers of warriors in tribes west of Missouri. (2 pages)

3. Draft of letter/notes (fragment). Draft begins: ". . . the robberies committed on our Sante Fee road . . ." Indian attacks along the Santa Fe road, probably by Arapahos; Major Dougherty's opinions of the Pawnees. (4 pages)

4. Draft of letter/notes (fragment). Draft begins: ". . . and have no doubt but they are now . . ." Defensive positions, Indians attacks and the British. (2 pages)

5. Draft of letter/notes (fragment). Draft begins: "notwithstanding all this I am . . ." Fear of unidentified Indian tribe aligning with the Arapaho and Blackfoot near the head waters of the south branch of the Platte River. (4 pages)

6. Draft of letter/notes (fragment). Draft begins: "Mr. Sublette is now in this neighborhood . . ." Sublette preparing for an expedition next spring; operations of the Hudson Bay Co. (2 pages)

7. Draft of letter/notes (fragment). Draft begins: ". . . they have considered at all times hostile to our trade . . ." Attempts to drive Indians from U.S. territory, while British traders supply Blackfoot tribes with arms and ammunition. (2 pages)

8. Draft of letter/notes (fragment). Draft begins: "you request me also to give you . . ." First paragraph regarding movement of parties of men; second a request for patent to be placed on tract of 600 acres, as legal representative of John Jones. (1 leaf, 1 page)

9. Draft of letter/notes (fragment). Draft begins: "on the arrival of the party at their camping ground . . ." Using packs as breastworks against night attacks of Indians; grass as supplemental food for horses during the night (in camp); setting up night camp and care of horses. (2 pages)

Draft of letters (fragment) (4 pages):

1. Begins: "Dear Sir. We are yet in Washington . . ." Weather in Virginia. (1 page)

2. Begins: "at day light (when in a dangerous part of the country). . ." Concerns mounted guards for camps and the creation of breastworks for defense against Indian attack. (3 pages)

1829 March 10

Draft of letter dated Washington City (fragment). Begins: "Sir, From my first observations in the region of the Rocky Mountains . . ." First four pages appear to be a draft of one letter. Pages 5-7 appear to be a draft of another letter, much like the first draft dated March 1829 (8 pages) (folder 17).

1829 Nov 12 Document signed H.L. Hoffman, H. von Phul. Deed of pew No. 30, Christ Church Cathedral (St. Louis, Missouri), to William H. Ashley, for \$125.

1836 Oct 19 Letter signed Sophia P. Gregory, Mt. Airy, to General Ashley. Cooper County, Mo. Seeks aid in starting a girl's school. Mentions a letter of introduction from Dr. Woodfolk of St. Louis.
